## PRIVACY POLICY

## Effective March 15, 2006

Protecting consumer privacy is a priority at Vn-Usa. Currently, this information concerning your privacy is only applicable to online transactions initiated by U.S. customers and visitors to our website. We may obtain this information from a variety of sources including, but not limited to the following: (a) directly from customer applications, questionnaires and other materials submitted to Us by the Sender; (b) from transactions in which Vn-Usa and Sender are involved; and (c) from a variety of third-party sources, such as government repositories, consumer reporting agencies and other financial institutions.

USE OF COOKIES AND WEB BEACONS: A "cookie" is a small text file placed on your computer's hard drive by a web server and which is acknowledged by your web browser. "Web beacons" are transparent electronic images placed in the web code, also called "clear GIFs" or "Web bugs." **DISCLOSURE OF INFORMATION:** Vn-Usa does not sell, distribute, or otherwise disclose your information to third parties without first obtaining your express written consent and giving you an opportunity to opt-out of such disclosure. There are some disclosures to third parties that are not subject to the opt-out, such as the following: disclosures necessary to effect, administer or enforce a transaction requested by You, to companies that perform services for Us, to prevent fraud; and, in addition, Vn-Usa may disclose information about former consumers or customers to third parties and companies with which Vn-Usa is affiliated. Those disclosures may consist of the following: (a) financial background information describing financial status; (b) identification information, such as name and address data; (c) transaction information, such as account activity, debit activity or credit activity; and (d) other information relating to financial matters.

**RECIPIENTS OF INFORMATION:** Vn-Usa may disclose your information to companies affiliated with Us. These recipients include: (a) financial institutions such as banks, and consumer reporting agencies pursuant to the Fair Credit Reporting Act (15 U.S.C. §1681 et seq.); (b) companies that process transactions or provide other services for Us including, but not limited to, attorneys, accountants, and auditors; and (c) government and law enforcement agencies in general and where specifically required or permitted under the Right to Financial Privacy Act of 1978 (12 U.S.C. §3401, et seq.), to comply with federal, state, or local laws, rules, and other applicable legal requirements, as required by Title III of the federal United and Strengthening America by Providing Appropriate Tools Required to Intercept and Obstruct Terrorism Act of 2001 (USA Patriot Act; P.L. 107-56).
